GENERAL MEETING

The upcoming general meeting of Pivotal Metals Limited (formerly Raffaella Resources Limited) (**Company**) is scheduled to be held at Level 8, London House, 216 St Georges Terrace, Perth, Western Australia 6000 on Thursday, 2 March 2023 at 3:00pm (AWST) (**Meeting**).

The Directors of the Company have made the decision to hold a physical Meeting on the basis that minimal shareholders attended the Company's 2022 general meetings held on 26 April 2022 and 23 September 2022 and 2022 annual general meeting held on 22 November 2022. Accordingly, shareholders will be able to attend the Meeting in person should they wish to do so. However the Company is continuing to monitor the impact of the COVID-19 virus in Western Australia and following guidance from the Federal and State Governments.

The Company will not be sending physical copies of the Notice of Meeting to shareholders (other than for shareholders who have requested to receive physical copies, which will be despatched to them). The Company **strongly encourages shareholders to lodge a directed proxy form prior to the Meeting**. Questions should also be submitted in advance of the Meeting as this will provide management with the best opportunity to prepare for the Meeting, for example by preparing answers in advance to shareholders' questions.

To assist the Company in ensuring that the Meeting is held in compliance with the COVID-19 restrictions at the time of the Meeting, it will be helpful for shareholders who wish to attend the Meeting in person to register their attendance by emailing info@pivotalmetals.com by no later than 3:00pm (AWST) on 2 March 2023 (**Attendance Closing Date**). This will greatly assist the Company to manage arrangements for the Meeting to comply with any changes to government restrictions which may apply at the time of the Meeting.
