ANNUAL GENERAL MEETING

The upcoming annual general meeting of Pivotal Metals Limited (**Company**) is scheduled to be held at Level 8, London House, 216 St Georges Terrace, Perth, Western Australia 6000 on Monday, 18 November 2024 at 1:00pm (AWST) (**Meeting**).
