Exciting progress across our Quebec copper, PGM and gold projects during the quarter ended 30 September 2025

Quarter Highlights

- ① **Substantial conductors delineated using detailed ground-based EM (FLTEM) surveys across multiple priority areas on the Belleterre projects.**
 - Alotta, extending 150m below sensational prior drilled copper hits, highlight 24m @ 2.3% Cu, 1.2% Ni & 1.9 g/t 3PGE (from 53.1m)
 - Lorraine Mine, undrilled conductor adjacent to previously operated Cu-Ni-Au massive sulphide mine (600kt @ 1.4% Cu, 0.6% Ni, 0.6g/t PGE)
 - Shanty Lake, 400 x 500m undrilled conductor, below mineralised gabbro outcrop
- ① **Defined the high-grade Lorraine gold target.**
 - Target definition expanding out from historical underground, where historical channel returned 28m @ 45 g/t Au along a vein.
- ① **\$5.4m in firm equity funding commitments (post quarter end).**
 - Strongly supported by institutional and strategic investors including well-known Australian resources investor Matthew Latimore, who will become a substantial shareholder in the Company.
- ① **Enhanced exploration program being implemented over the next 6 months, including:**
 - Drilling multiple priority high-grade Cu-PGM targets
 - IP survey and planned drilling at the high-grade Au target
 - Target generation and testing across regional scale property, including extensive use of geophysics to continue to grow the Belleterre discovery pipeline
 - Resource and economic optimisation activities at Horden Lake
- ① **Cash balance at 30 September 2025 of \$0.977m, with \$5.4m gross receipts expected in the 4th quarter.**

Managing Director Ivan Fairhall said: “Increased focus at Belleterre has compounded the value creation opportunity within our high-quality portfolio of projects in Quebec.

“The identification of multiple new undrilled conductors at Belleterre highlights the quality and widespread potential across this large 100% owned land package. We are vectoring off sensational copper and gold mineralisation, with new methods in undrilled areas supporting genuine new discovery potential. Belleterre complements our recently enlarged advanced Horden Lake project underscoring the significant asset base of the Company.

“The \$5.4m funding announced post-quarter end is transformational for Pivotal, and we are now well financed to accelerate drilling at Belleterre. The backing from important strategic and institutional shareholders is a strong endorsement of our projects, and we are appreciative of the support from shareholders old and new for our Company and strategy.”

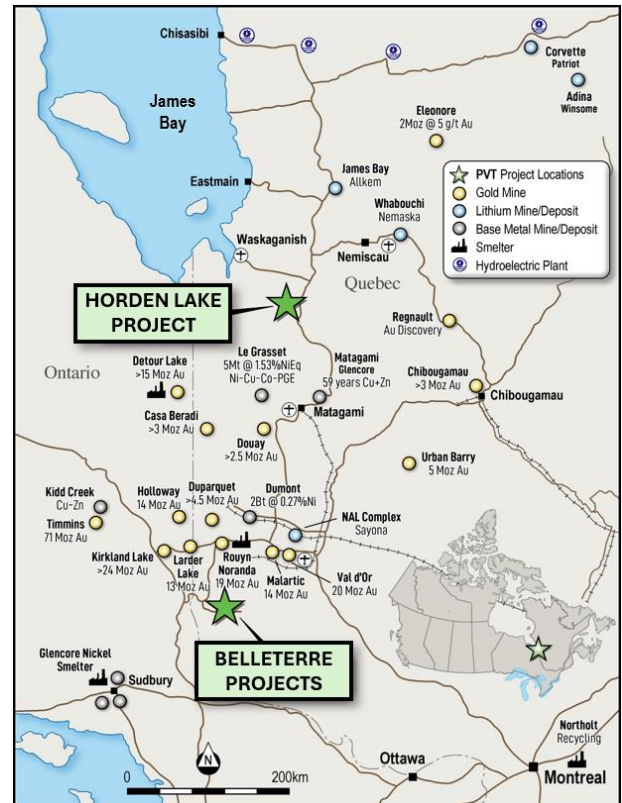
OPERATIONAL UPDATE

Pivotal is developing two major projects at Horden Lake and Belleterre located in the Province of Quebec, Canada. Both represent high quality exploration and development opportunities in a global leading mining jurisdiction.

Our 100% owned Belleterre Projects consist of a large 160km² greenstone land package encompassing three key project areas: Midrim-Alotta, Lorraine and Laforce. All projects demonstrate advanced exploration prospects, with multiple very high-grade Cu-Ni-PGM and Au occurrences and targets, historic resources, and some with prior mining.

Our 100% owned Horden Lake project is well advanced with a large copper dominant JORC compliant indicated and inferred mineral resource estimate totalling 37mt @ 1.1% CuEq (Table 1) There is significant exploration upside potential to compound value of the large predominantly open-pit constrained resource already defined.

Pivotal is focused on advancing both projects, by generating and drilling new targets for resource definition and growth, alongside technical de-risking to enhance the valuation of its discoveries and attract additional funding.



EM Surveys Delineate Multiple Drill Targets

During the quarter Pivotal completed EM surveys across multiple exploration targets across the Belleterre package. Belleterre is a large land package and host to a large number of exploration targets. Pivotal has been prioritising targets with all or a combination of aerial geophysical anomalies, association with high-grade mineralisation at surface or in prior drilling / mining, and favourable geological setting. Given the prevalence of massive sulphides in prior exploration and mining, and limited depth of exploration coverage, fixed loop surveys have been deployed to provide high resolution data and constrain targets for drilling.

New Conductors at Lorraine Mine and Shanty Lake

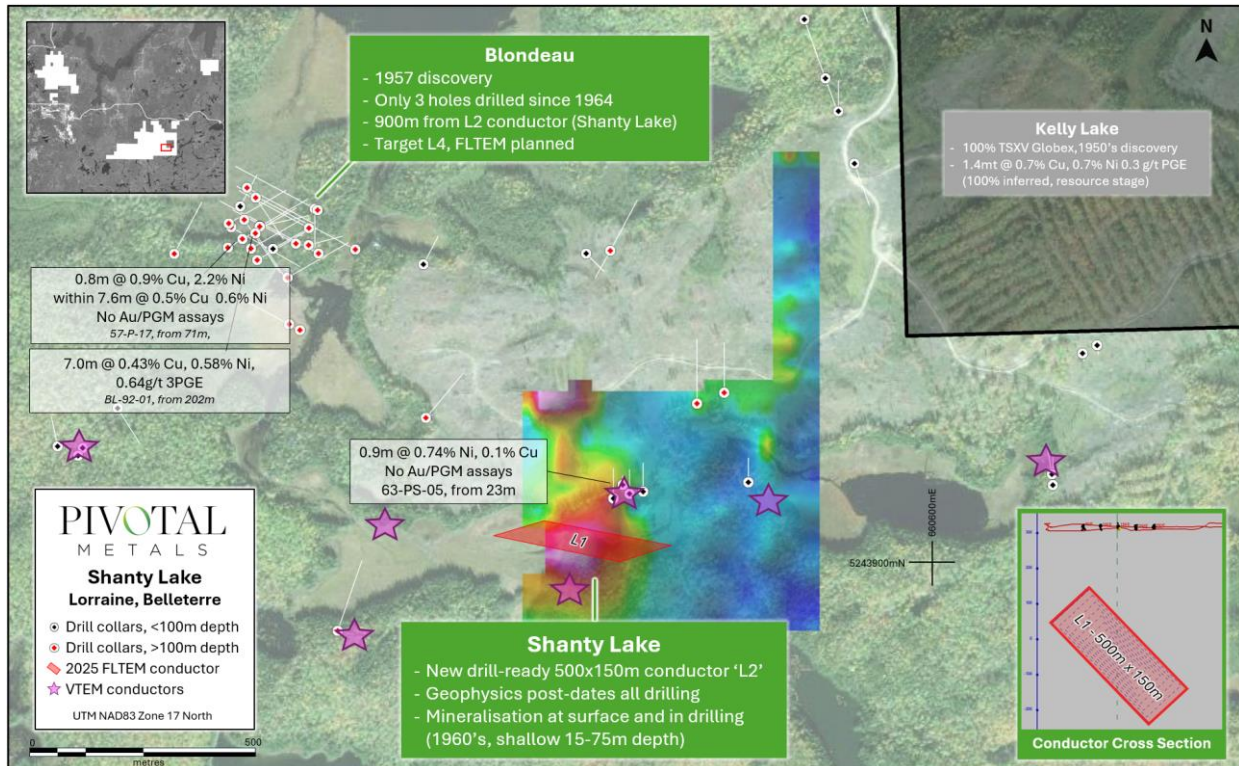


Figure 1: Shanty Lake FLTEM, showing total field intensity (channel 15) and modelled conductor 'L1', coincident VTEM anomalies and proximity the Blondeau and Kelly Lake deposits.

The Shanty Lake magmatic sulphide Cu-Ni occurrence lies between the Blondeau and Kelly Lake Cu-Ni deposits. Pivotal's 2025 FLTEM survey identified a large 400m x 150m steeply dipping bedrock conductor (Figure 1), starting from 150m depth beneath the Shanty Lake surface occurrence.

Based on mapping the target horizon is interpreted to be underlain by mafic volcanic and gabbro. Previous drilling and grab and boulder samples returned elevated Ni and Cu concentrations. The combination of known prospective host environment, established mineralisation, VTEM conductor, and FLTEM conductor makes Shanty Lake a highly prospective and priority drill target.

The Lorraine mine is a massive sulphide Cu-Ni-Au deposit with 1960s historic production totalling 600kt @ 1.4% Cu, 0.6% Ni and 0.6 g/t Au. Subsequent investigations have identified VTEM conductive anomalies, broadly coincident with off-hole DHEM conductors, immediately northeast of the mined area.

Pivotal's FLTEM survey validated the existing VTEM anomaly now interpreted as moderate-high conductivity and likely oriented sub-vertical and parallel to the FLTEM survey lines. A follow-up FLTEM survey is underway, optimised for a different conductor orientation ahead of drilling.

None of the conductors have been drill tested and the areas represent high-priority targets for new discovery. Targets are located immediately adjacent to the mined Lorraine massive sulphide body are within a known complex mafic volcanic and gabbro environment providing excellent conditions for massive sulphide emplacement.

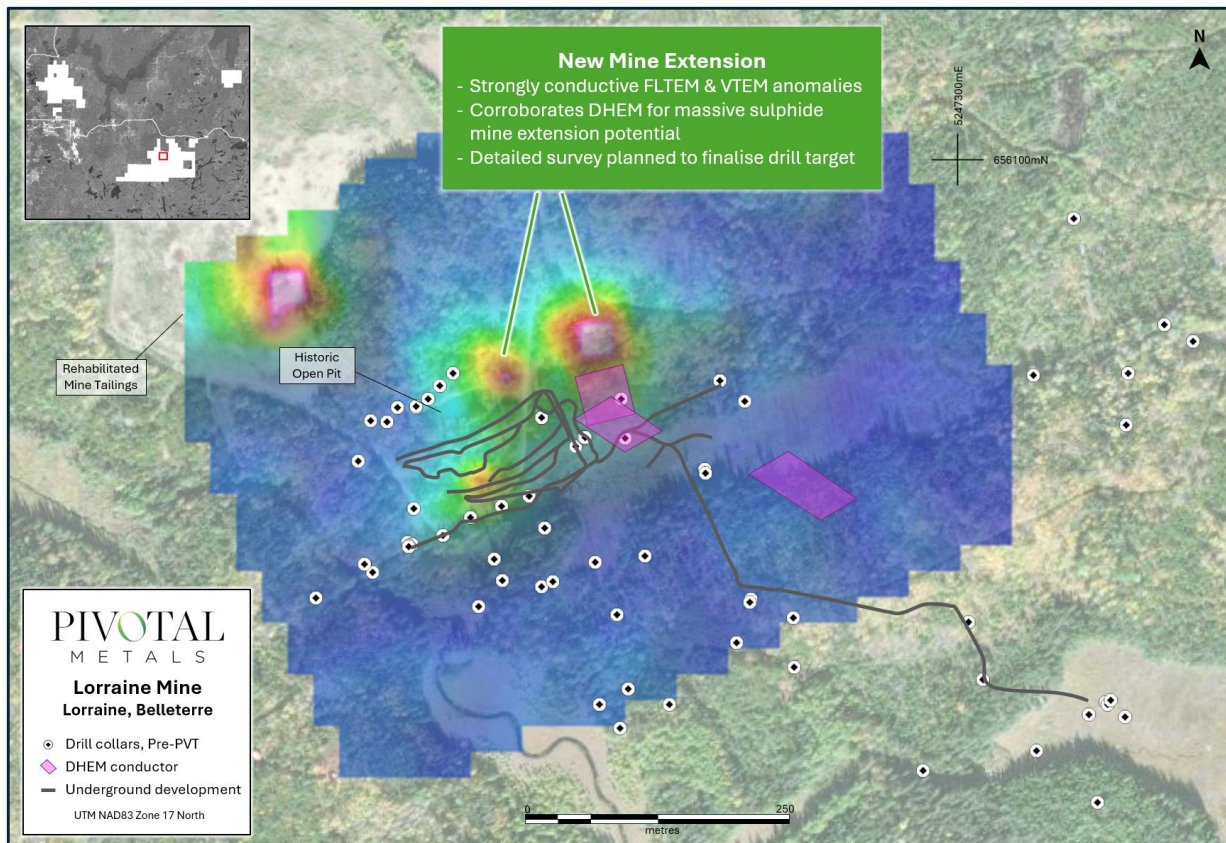


Figure 2: Lorraine Mine Cu-Ni-Au extensions, showing FLTEM total field intensity (channel 15)

New Alotta Conductor (results announced post reporting period)

The FLTEM survey has delineated a large conductive plate positioned directly beneath the known zone of massive magmatic sulphide mineralisation at Alotta which hosts very high-grade copper, nickel, platinum and palladium values from surface to approximately 90 metres depth. Importantly, the new conductor indicates that the optimal drill orientation is from the northeast, contrasting with historic drilling which was completed from the southwest.

This newly interpreted Alotta conductor extends the deposit potential by an additional 150m down-plunge, with the plate remaining open to the east due to seasonal limitations in survey coverage.

Follow up surveys and drilling are expected to commence in late-Q4 25.

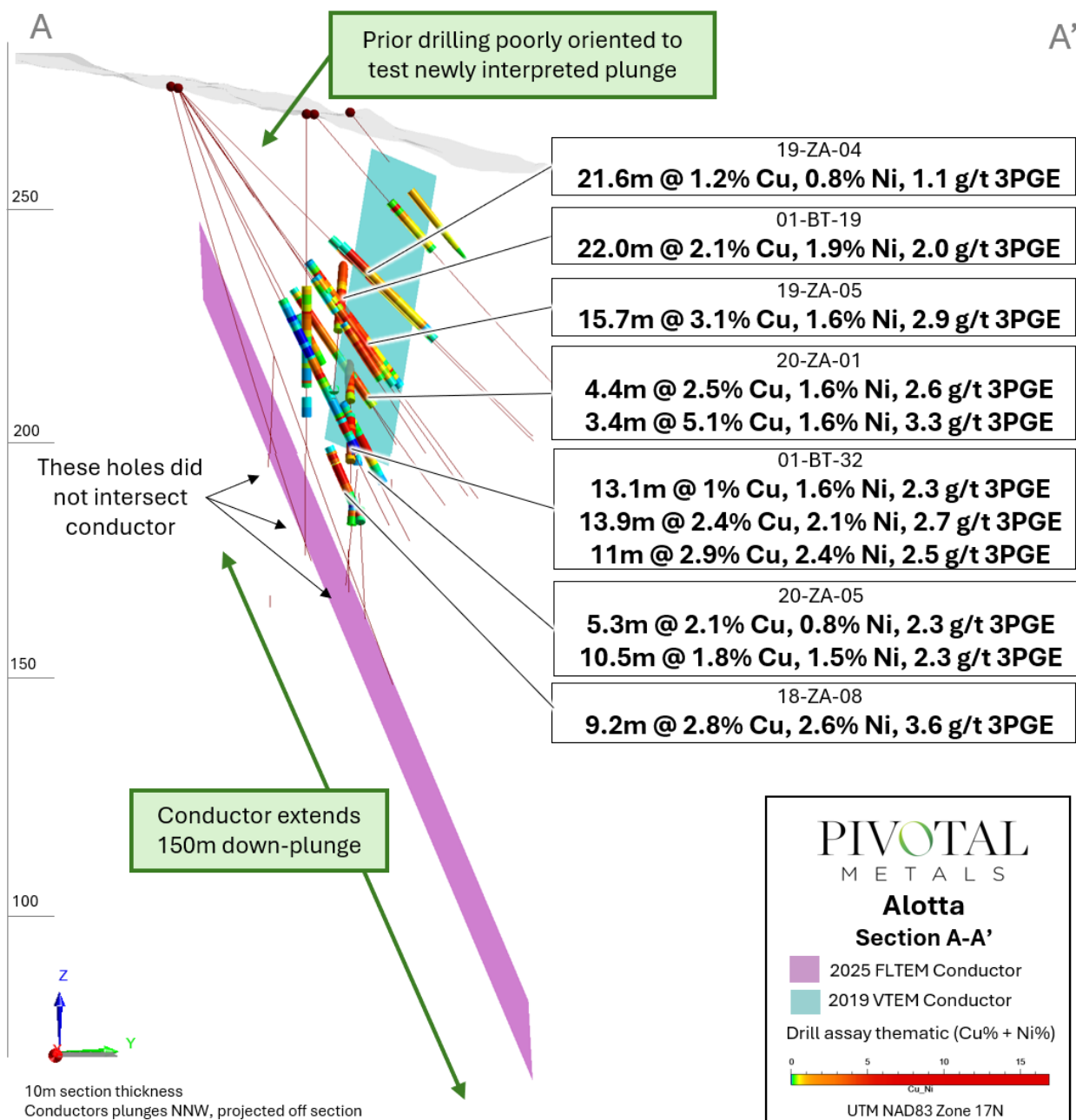


Figure 3: Section view of Alotta showing high-grade mineralisation and interpreted FLTEM conductor extending strongly down-plunge. Note orientation of prior drilling poorly oriented to intersect newly interpreted plunge.

New conductors were also delineated in the north of the Midrim property, at Lac Long and Lac Kirwan.

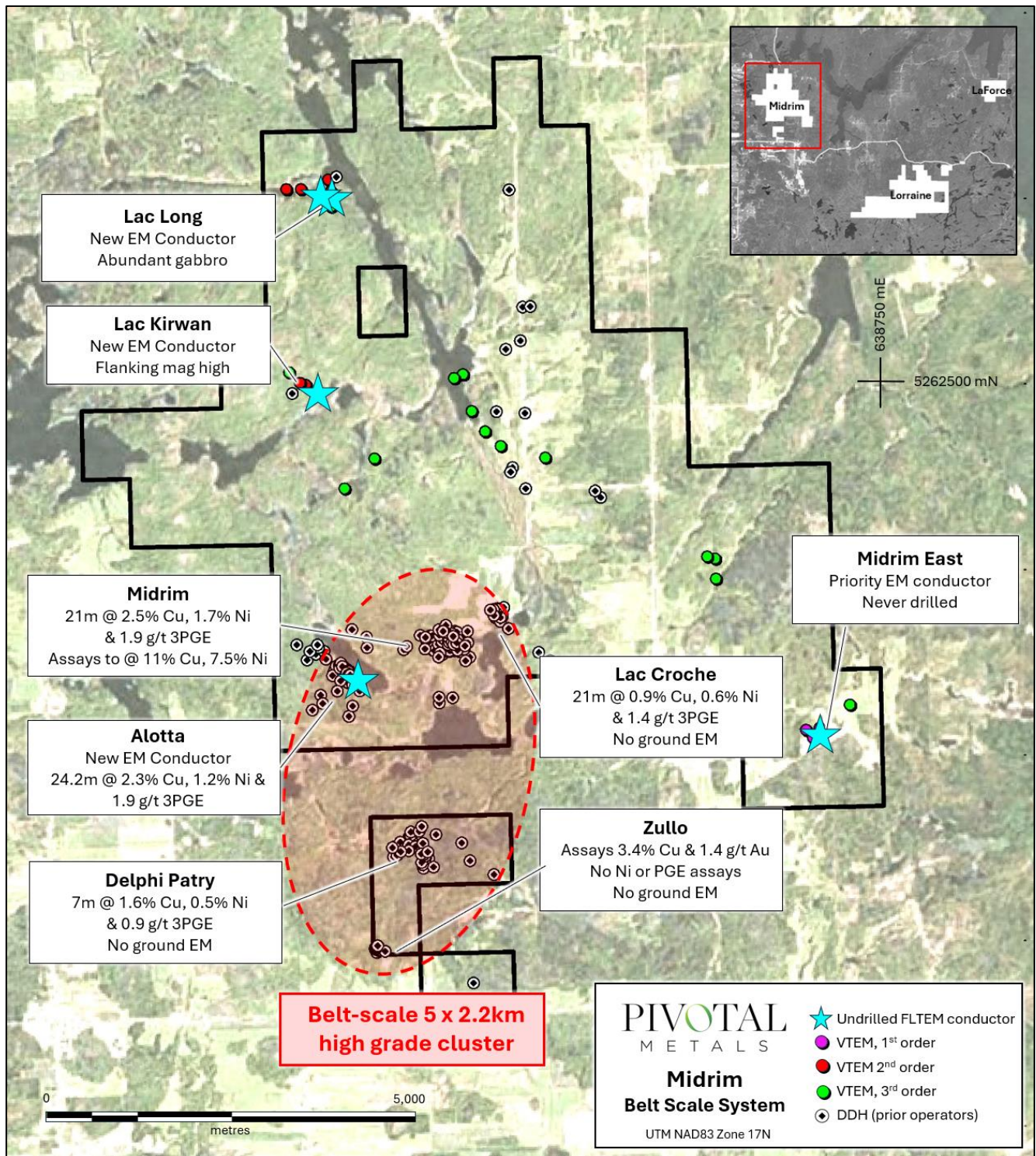


Figure 4: Midrim project area showing widespread high grade mineral occurrences and geophysical anomalism, and limited drilling outside of the historical target areas

The Midrim property Figure 4 has demonstrated widespread high-grade mineralisation and geophysical anomalies, and remains highly prospective for new discovery.

High Grade Gold at Lorraine

Investigation of the recently extended the high-grade gold corridor at Lorraine is ongoing with the company preparing for a planned IP geophysical survey ahead of potential drilling and follow-up outcrop stripping.

Recent soil sampling results indicate a significant corridor of potential gold mineralisation extending east from the historic bonanza grade gold channel samples (28m @ 45 g/t) and drilling (1m @ 53 g/t Au) encountered in underground development at the 1960's Lorraine Mine operation (refer ASX [4 June 2025](#)). A recent five sample soil infill program around the outlier 1.09 g/t soil original result did not return significant gold assays.

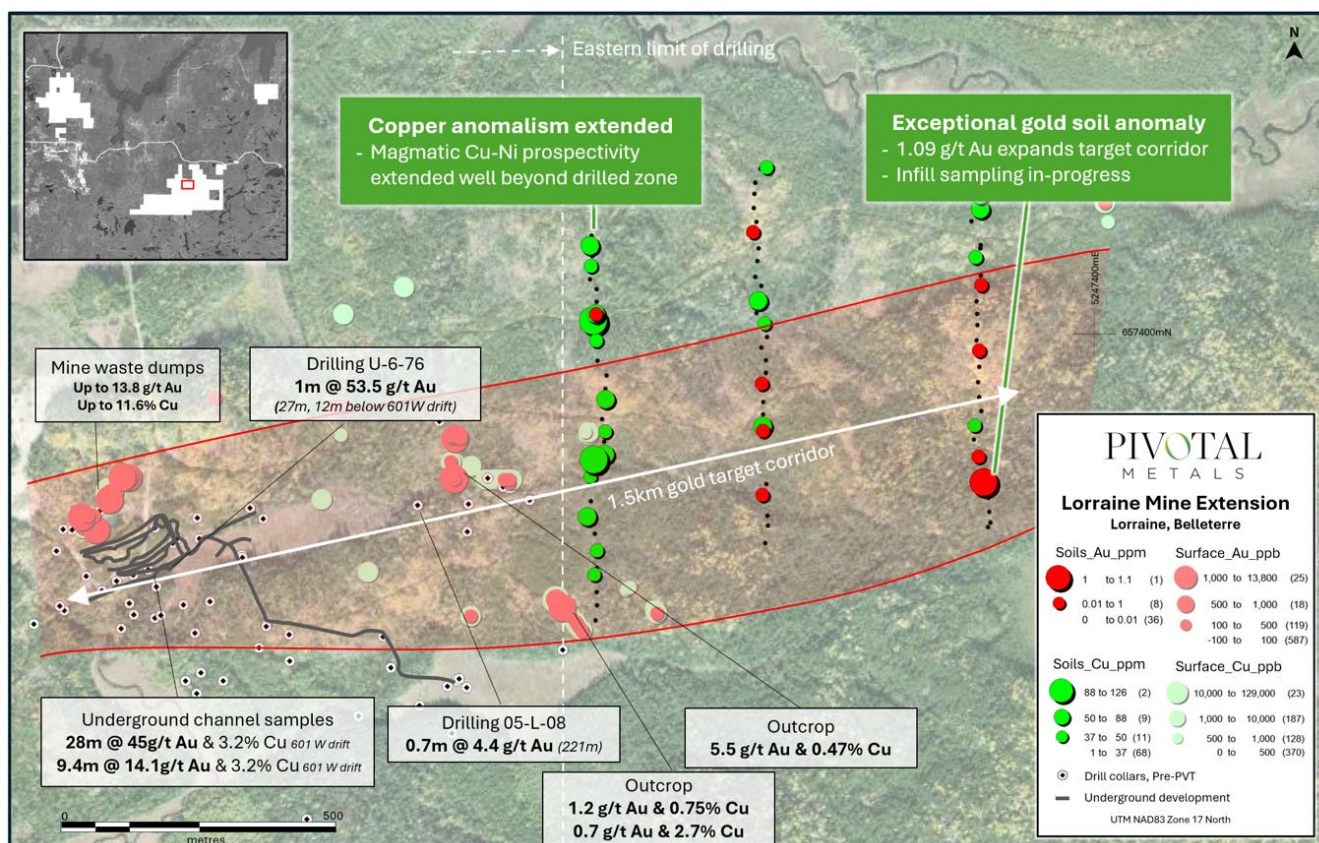


Figure 5: Lorraine Mine gold high-grade gold target.

Horden Lake

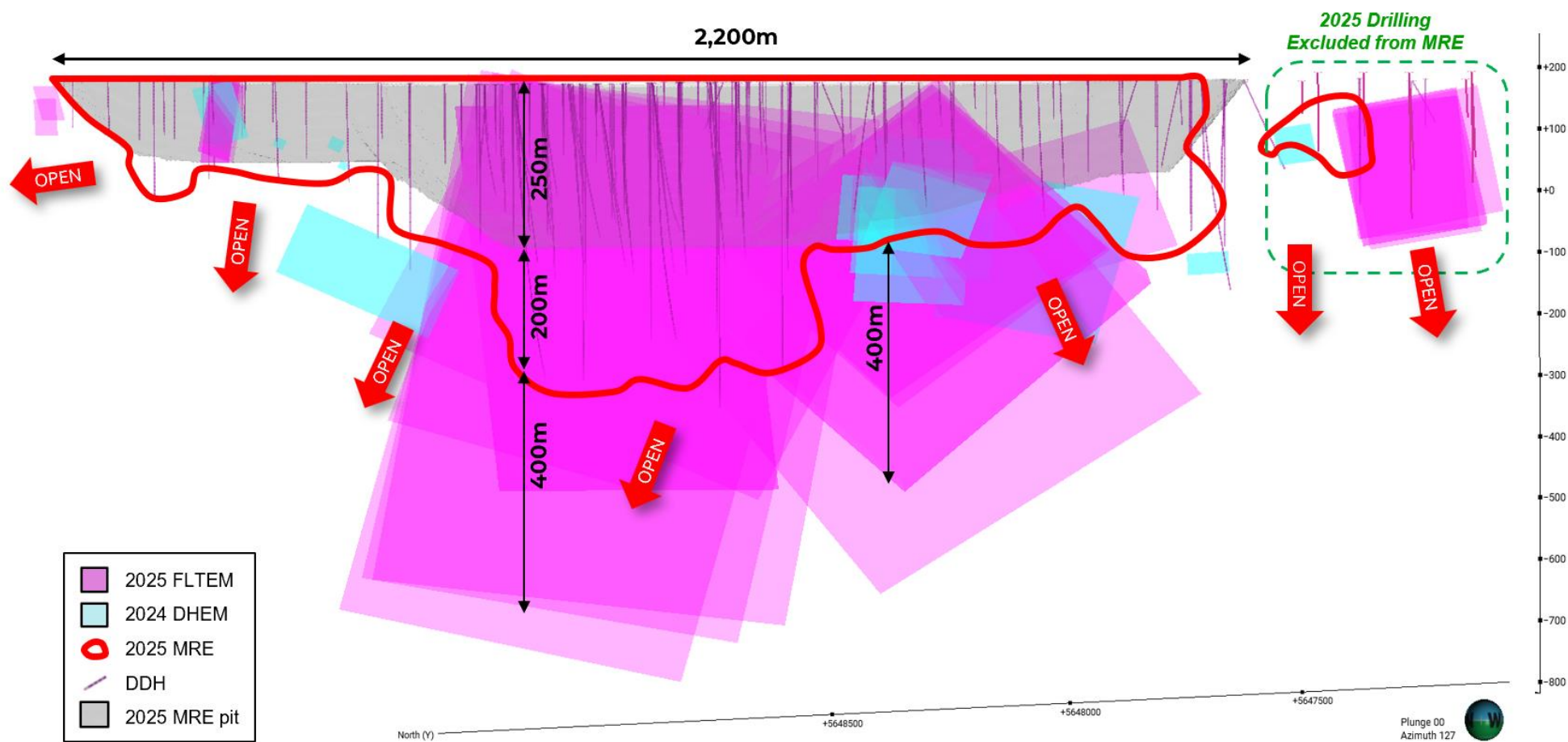


Figure 6: Long section looking SE outlining the 2025 Horden Lake MRE superimposed onto the modelled conductor plates interpreted to represent the potential continuation of the Horden Lake sulphide mineralisation.

On 26 April 2025, Pivotal declared an updated inferred and indicated mineral resource estimate at its advanced Horden Lake project, in the James Bay region of Québec. The project now hosts 37mt @ 1.1% CuEq, importantly with 31mt @ 1.1% CuEq being constrained in a large single pit constrained resource (refer Table 1 for full breakdown and Table 2 for CuEq). EM surveys outline substantial resource upside, including a shallow along strike conductor that was drilled in March 2025 and excluded from the MRE (Figure 6). Furthermore, March 2025 metallurgical testwork has shown the production of high-grade copper and nickel concentrates can be delivered from a conventional flotation flowsheet.

During the quarter, the Company advanced a number of exploration and economic optimisation activities aimed to guide the future drilling and development activities. Important results of this work will be released as they become available.

FORWARD PROGRAM

Following the October placement (refer below), the Company is ramping up an expanded exploration program focused on its Belleterre properties.

- ① Expand and refine EM survey over Alotta and Lorraine conductors (Q4 2025)
- ① Drilling of high-priority EM conductors, (late-Q4 2025)
- ① IP survey over Lorraine gold trend (Q4 2025) to support drill targeting
- ① Extend EM coverage across the entire La Croche-Zullo area, to build on success at Alotta (Q1 2025)
- ① Mapping, sampling and EM of additional Cu-Ni-PGM and Au targets across the wider Belleterre land package (ongoing, starting Q4 2025)
- ① Further studies to support development and exploration planning at Horden Lake (ongoing)

CORPORATE UPDATE

Pivotal's cash position as at 30 September 2025 was \$0.977m.

On 24 October, the Company announced firm commitments to raise A\$5.4m in gross funding via the issue of equity.

- ① C\$2.62m (~A\$2.89m) via placement utilising generous Canadian flow through share scheme, completed at a premium to the concurrent placement. Utilising this scheme yielded the Company A\$1.1m in non-dilutive funding.
- ① A\$2.5m via a placement to sophisticated and institutional investors. A\$1.8m, inclusive of A\$90k commitments from Pivotal directors, will be subject to shareholder approval at a general meeting to be convened for mid-December.

Financial commentary

The Appendix 5B for the quarter ended 30 September 2025 provides an overview of the Company's financial activities. Exploration expenditure for the quarter was \$0.320m for ongoing study work associated with the Company's projects. Corporate and other expenditure for the quarter was \$0.253m. The total amount paid to Directors of the Company, their associates and other related parties was \$0.137m and includes salary, fees and superannuation.

In the opinion of the Company, all elements included in the metal equivalent calculation have a reasonable potential to be sold and recovered, based on current market conditions, metallurgical testwork, and the Company’s metallurgical consultant’s experience. Copper is chosen as the equivalent metal due to its dominant economic average weighting at the assumptions stated, which is consistent across the deposit area.
